Overview of Workforce Investment San Francisco

Ms. Simmons commented on the structure of the Workforce Investment San Francisco (WISF) Board and how the Workforce Investment Community Advisory Committee (WiCAC) will advise the WISF on improving the workforce system as a whole and capacity building issue.

Overview of Strategic Plan

Mr. Dexter Ligot-Gordon, presented on the Workforce Development Strategic Plan that was approved at the October 28, 2009 WISF meeting.

Public Comment

The call for public comment yielded the following response:

Mr. David Bach, LGBT Center, commented on his concern about having the technology in place that was bid out in RFP #107 in place in order to place his clients in jobs.

Mr. Troy Henry, Goodwill of San Francisco, commented on the use of the Virtual One Stop system that was bid out in RFP #107 and is in the process of being developed by OEWD.

Mr. Joe Ramirez-Forcier, PRC, commented that he was not in favor of the sector based strategy as an effective strategy for individuals with multiple barriers to employment and suggested that the environmental scan be revisited.

Hasida Sinaga, RAMP-Hireability, commented on her concern about placing clients that she serves within the union trades due to their strict requirements.

Mr. David Bach, LGBT Center, commented on the difficulty of service providers to engage with the unions in placing clients.

Mr. Troy Henry, Goodwill of San Francisco, commented that with enhanced business services they have been meeting with the unions on a monthly basis and there have been challenges, however, the unions are at the table and willing to have a dialogue.

Ms. R. Niribe, SFLC, commented that she would like to invite everyone to the table to have a conversation about difficulties that service providers have in placing clients with the unions.

Ms. Christine Galvez, Community Housing Partnerships, commented that she wanted to make sure that we did not create an environment where one group of job seekers was fighting with another group of job seekers.
