ACCESSIBLE MEETING POLICY

1. The meeting will be held at the Office of Economic and Workforce Development, Workforce Division, located at One South Van Ness Avenue, 5th Floor, San Francisco, CA 94103. The room is wheelchair accessible and has accessible seating for persons with disabilities and those using wheelchairs.
2. The closest accessible BART station is Civic Center. Accessible MUNI lines serving this location are: #14/14L Mission, #19 Polk St, #71 Haight/Noriega, #5 Fulton, #21 Hayes, # 6 Parnassus, #9/9L San Bruno, the F Line to Market and Van Ness Avenue and any line serving the Metro Stations at Van Ness Station.
