Chair Toni Rucker called the meeting to order at 9:15 am.

Agenda

Minutes from the November 29, 2012 meeting were approved. The agenda for today's meeting was approved. After announcements by Chair Toni Rucker, John Halpin welcomed Dr. Rucker as the new Chair of the Subcommittee and recognized Jennifer Hermann for her work as Chair over the past 2 years. He noted highlights of the City's new 5-year workforce strategic plan approved by the WISF in June 2013 and the large RFP/procurement process which took place this past fall. The plan and contracts are aligned around industry sectors with projected regional growth, and the Citywide entry points for jobseekers to access workforce services are now called Access Points, instead of One Stop Career Centers.

Deborah Dobin presented an industry analysis and overview of the City's Healthcare Academy training

and job search programs. Toni Rucker introduced the discussion by asking if there were specific questions from subcommittee members or others. A number of questions were posed about healthcare workforce needs, with lively discussion following each one.
