1) On the Treasurer/Tax Collector's website, scroll over the word property and click "Property Tax" payments.



2) On the next screen, ensure that Secured Property Tax is selected and then click "Access My Bill"



3) On the next screen, enter in either the property's address or Assessor's Parcel Number (APN). If you are having trouble locating your APN, please utilize the Property Information Map on the resources page. Once the information is input, click "Begin Search."
