- You have a valid CA driver's license/AB60
- Meet income guidelines
- Own a vehicle valued at \$25,000 or less
- Be at least 16 years old

CDI & DMV COVID Updates

CALIFORNIA DEPARTMENT OF INSURANCE

- May 15, 2020: <u>Commissioner Lara expands order for insurance companies to partially refund premiums amid</u> <u>ongoing COVID-19 pandemic</u>
- May 15, 2020: <u>Notice of Extended Grace Period for Insurance Premium Payments Due to Disruption Caused</u> by the COVID-19 Pandemic extends to July 14, 2020 from previous <u>March 18, 2020 Notice</u>

CALIFORNIA DEPARTMENT OF MOTOR VEHICLES

- <u>Waiving late fees</u> and penalties for vehicle registration renewals due between March 16 and May 31, 2020, and *paid within 60 days of the original expiration date*
- DMV has <u>extended driver licenses that expire between March and July 2020</u> through July 2020, and has expanded eligibility to <u>renew online</u>
- <u>REAL ID</u> enforcement postponed to Oct 1, 2021
- There are 71 DMV offices open. DMV's Virtual Field Office, <u>virtual.dmv.ca.gov</u> is available to assist with more complex transactions that would normally require a representative. It is an interactive transaction with a DMV agent, conducted via email, phone, or chat.
- *Kiosks still available for simple transactions like getting your vehicle registration sticker or filing a non-operation.*
