Program Area A: Activation for Economic Core Recovery

Maximum Budget Request: \$500,000* Anticipated # of Awards: Up to 8

Total Funding: OEWD expects to allocate a total of \$2 Million for initial awards, and may increase any single award up to \$2.5M through a grant renewal.

Target Neighborhoods: Financial District, Union Square, East Cut, Yerba Buena, South of Market Area (SOMA), Embarcadero, Mission Bay, and Market Street

Target Population(s): Small businesses, residents and property owners in the economic core neighborhoods, prioritizing those with the most sustained economic impacts from the COVID-19 pandemic.

- Grants will fund activation activities in public spaces and vacant storefronts, with the goal of driving foot traffic to the neighborhood(s) and encouraging workers, residents and visitors to build community
- Budget requests can range between up to \$100k for smaller scale activations, and \$500k for larger/ongoing activations
- Evaluation Process will include splitting submitted proposals into the target neighborhood(s)



Program Area B: Economic Core Recovery Area-Wide Planning and Communications

Maximum Budget Request: \$250,000 Anticipated # of Awards: 1 to 2

Total Funding: OEWD expects to allocate a total of \$250,000 for initial awards, and may increase any single award up to \$1M through a grant renewal.

Target Neighborhoods: Financial District, Union Square, East Cut, Yerba Buena, South of Market Area (SOMA), Embarcadero, Mission Bay, and Market Street

Target Population(s): Businesses, residents and property owners in the economic core, as well as the labor force with jobs based in the economic core neighborhoods, prioritizing those with the most sustained economic impacts from the COVID-19 pandemic.

- Grants will support management of community engagement and convening efforts citywide, across multiple stakeholder groups, to market and communicate out the City's economic recovery activities and opportunities
- Proposals should focus on how your agency/project team can leverage existing relationships in the
 economic core neighborhoods, and build strategic partnerships toward the goals of attracting
 residents and visitors to key economic corridors, expanding economic opportunity, and increasing
 the accessibility of public space

Program Area C: Pop-up Acceleration and Technical Assistance

Maximum Budget Request: \$600,000 Anticipated # of Awards: 1 to 3

Total Funding: OEWD expects to allocate a total of \$600,000 for initial awards, and may increase any single award up to \$1.5M through a grant renewal.

Target Neighborhoods: Citywide, with initial emphasis on Financial District, Union Square, East Cut, Yerba Buena, South of Market Area (SOMA), Embarcadero, Mission Bay, Market Street

Target Population(s): Small businesses, entrepreneurs, artists and cultural organizations, and economic core property owners, prioritizing those with the most sustained economic impacts from the COVID-19 pandemic.

Grants will support groups that can ensure the success of pop-up activation activities, including but not limited to:

- Outreach to property owners for temporary activations
- Outreach to entrepreneurs, micro and small businesses, artists, arts organizations, cultural institutions, others to activate program spaces
- > TA and consulting on business plans, budgets, and revenue generating strategies to ensure success
- > TA and support to potential pop-up entities in negotiating leases, licenses, insurance, security, etc.
- > TA and support in navigating permitting requirements
- ➤ Issuing micro-grants (\$1k-\$10k) to cover activation costs
- Partnering on marketing efforts



Program Area D: Visitor Attraction Campaign

Maximum Budget Request: \$600,000 Anticipated # of Awards: 1 to 2

Total Funding: OEWD expects to allocate a total of \$600,000 for initial awards, and may increase any single award up to \$2.5M through a grant renewal.

Target Neighborhoods: Citywide

Target Population(s): Domestic and international tourists, meetings and convention professionals

Grants will support the development of a marketing campaign focused on San Francisco's economic recovery. The ideal campaign will include some or all of the following strategies:

- > Resonant visual images with a strong call to action
- Traditional media (TV, billboards in key domestic and international markets)
- Digital media, social media, influencers
- > Public relations and communications that reinforce campaign messages
- Grassroots marketing opportunities to increase awareness of the campaign.
- Other creative strategies may be proposed.

First become a Registered Bidder...

The first step to begin working with the City is to <u>complete a short registration process</u> to become a "Registered Bidder". This will allow you to view and bid on Sourcing Events.

...then Become an Approved Supplier

After becoming a Registered Bidder, you can then advance your status to become an Approved Supplier, which allows you to be fully awarded City contracts. The steps to do this are as follows:

- 1 Complete a San Francisco Business Tax Registration
- 2 Complete a 12B Equal Benefits Declaration



Supplier Instructions – Business Tax

- To renew your tax registration, visit
 https://sftreasurer.org/busines s/renew-business-registration
- San Francisco businesses were required to renew their business registration by May 1, 2022 for the current year, and typically renewal is required each May.

Supplier Instructions – Equal Benefits (12B)

1	Have your username and password ready. Tip: If you do not have a username and password, contact the User Support Desk at Dtis.helpdesk@sfgov.org
2	Have the verification of employee count and verification of equal benefits ready.
3	Go to the Supplier Portal at https://sfcitypartner.sfgov.org/
4	Returning Users: Click the Log In button. New Users: Under the Help drop-down menu, select the Become a Supplier option.
5	Returning Users: Under the Get Started menu, click the Log In button and log in. New Users: Under the Get Started menu, click the complete a short registration process link and follow the steps for Bidder Registration.
6	Returning Users: Select 12B Declaration under the Certifications menu. New Users: go to Step 3, above, and follow the instructions for a Returning User.
7	Select 12B Declaration.
8	Ensure the SetID field is set to SHARE.
9	Click Add A New Value (for a new Declaration) or Find An Existing Value (to locate a previous Declaration).
10	Under Declaration Type , select Supplier if you have a Supplier ID. If you do not have a Supplier ID, select Bidder . (Bidder numbers start with "B")
11	Enter your Supplier ID. If you do not have a Supplier ID, enter your Bidder ID.
12	Follow the prompts to complete the 12B Declaration. IMPORTANT: Failure to attach the required supporting documentation will prevent compliance.
13	At the end of the Declaration, click the following buttons in this order: Save, Print, Submit, Cancel or Submit. Tip: Note the Declaration Number at the top of the page in case you need to contact the Equal Benefits Unit.
