Executive Order with authorizing public meetings via teleconferencing

- 1. The meeting will be held at the San Francisco War Memorial & Performing Arts Center, Veteran's Building, Green Room, located at 401 Van Ness Avenue, (between McAllister and Fulton Streets) San Francisco, CA 94102. The room is wheelchair accessible and has accessible seating for persons with disabilities and those using wheelchairs.
